Renee, Bill:

See email chain below; we need to talk tomorrow. I wanted to let folks know well in advance of what we will need to complete the effort, on schedule. We are on schedule now, and absolutely need to be because we have NO wiggle room.

Folks in the AKOCSR already know that approval of A/L during the Holidays will be minimal and on a case-by-case basis depending on their particular assignment and where it fits into the process. For example, in order to get to a Final SEIS Management, HQ, SOL review will be December 20-24.

Right now we are at Step 24 of the 52 individual steps.

FYI, the folks mentioned below were specifically selected because of their expertise; familiarity with Regional Staff & Management; and, in particular, their "collaborative" track records. No time to build relationships; need to hit the ground running.

Finally, as Janice Schneider told a number of external folks up here last week, "we are keeping to this schedule to allow Shell the opportunity to make a decision about next year's open water drilling season."

We now have the EP in house and there is an expectation that the ROD will be signed in March allowing Shell to make a decision.
